To the parent or guardian of

ORDER OF
EMERGENCY EXCLUSION
FROM SCHOOL

(student's name)

You are hereby notified that your child (named above) is prohibited from attending school until you establish that he/she is in compliance with the Washington State Immunization Law. Your child's emergency exclusion from school is effective immediately upon your receipt of this notice. The reason for this decision is that you have not submitted a Certificate of Immunization Status, or information provided was incomplete (copy attached) in behalf of your child. In order for your child to continue attendance at school you must complete this form and establish any one of the following:

- (1) That your child has received the required doses of vaccine; or
- (2) That your child has initiated a schedule of immunization; or
- (3) That you claim an exemption of your child from the immunization requirements for a medical, or religious, or personal, or philosophical reason.

You are further advised that you have a right to appeal or contest the decision to exclude your child from school. To appeal this decision you must provide the school district hearing officer, Chris Borgen, or his office, a written or oral request for a hearing no later than the tenth (10th) school business day following the date of your receipt of this notice. A schedule of school business days is attached. If you request a hearing, the only thing to be decided is whether your child either (1) meets the immunization requirements of the law, or (2) has been exempted at your request for one of the reasons stated above.

The immunizations and the number of vaccine doses required by law (except for exempted children) are as follows:

DPT — Diphtheria/Pertussis (whooping cough) /Tetanus: for entry level students (K or grade 1)) — at least four doses of DPT, DT, or Td vaccine, provided that the last dose was received at or after age four; for transfer students and those above Kindergarten or Grade 1, at least three doses are required.

Polio: at least three doses of trivalent poliomyelitis vaccine, provided that the last dose was received at or after age four.

Measles: one dose of live virus measles (rubeola) vaccine administered at or after one year of age, or documentation of measles immunity with laboratory titer results attached. A second dose of measles vaccine is required for students reaching 6th grade or age 13, whichever comes first.

Rubella: one dose of rubella vaccine administered at or after one year of age or documentation of immunity with laboratory titer results attached.

Mumps: one dose of mumps vaccine administered at or after one year of age or documentation of immunity with laboratory titer test results attached.

Hib: Haemophilus influenza; require proof of immunization with Hib vaccine for preschool children under five years of age.

Vaccines required to immunize your child may be obtained from your own doctor, or through the local health department or other public agency at reduced or no cost. A list is attached which provided you with the names, addresses and phone number of local public health clinics. PLEASE CALL THE SCHOOL AT ONCE FOR ADDITIONAL INFORMATION AND ASSISTANCE.

COMMUNICABLE DISEASES

The policy of the Anacortes School District is to comply with State Board of Health rules when dealing with students or staff who are suspected or determined to have communicable diseases.

The Superintendent or designee is directed to develop procedures, which provide for:

1. the health and safety of both the affected individual(s) and those who come in contact with them;
2. rights of privacy;
3. rights of public education;
4. due process rights of the infected, and
5. a comprehensive district educational program to minimize the spread of disease.
